The Invocation was given by Borough Manager/Secretary P. Michael Coll, followed by the Pledge of Allegiance to the Flag.

Consideration was given to the minutes of the November 5, 2018 Regular Borough Council Meeting and the November, 2018 Work Sessions. A motion was made by Councillor Richard Halbom, seconded by Councillor Richard Godshall, to approve the minutes as presented. The motion was approved.

Mayor John Reynolds commented on the Holiday Parade which was very well attended. The tree lighting event later in the evening was well attended for the weather conditions.

Police Chief James Leary noted that the monthly statistical and narrative reports will be distributed to Borough Council at the next available Work Session. Chief Leary is evaluating the crossing guard posts as we move into the 2019 Budget year.

Borough Solicitor Charlotte Hunsberger distributed their monthly report. All documentation for the 2019 Tax Anticipation loan had been filed. The Borough Solicitor expects to complete settlement in December for the transfer of the rear lot on N. Main Street from RVP, II to the Borough.

Public Works Director Steven Coll distributed his monthly report to Borough Council. Crews will focus on completing leaf collections in the coming weeks. Leaf collection has been a challenge with weather conditions and the completion of a few scheduled projects.

Borough Manager Michael Coll noted that this will be the last formal meeting of Souderton Borough Council for the 2018 calendar year. The Souderton Planning Commission will be meeting on Wednesday, December 5, 2018, with a number of presentations expected. The next regular meeting of Souderton Borough Council will be held on Monday, January 7, 2019.

Borough Manager Michael Coll reviewed the agenda items scheduled for consideration. Representatives for the proposed North End Market at 140-142 N. Main Street are present in the audience. The Souderton Planning Commission and Montgomery County Planning Commission have reviewed and recommend approval of this redevelopment project. The Borough has been working with our insurance broker and employees to develop a new high deductible health insurance program, with a Health Savings Account and Health Reimbursement Arrangement. Resolutions have been prepared to formally establish a Section 125 Cafeteria Plan, HSA and Health Reimbursement Arrangement. Advanced Disposal will begin their three year trash collection contract on January 1, 2019. Staff is working with both J. P. Mascaro and Advanced Disposal on the transition. A Resolution has been prepared for formal

consideration which sets forth the trash collection fees beginning January 1, 2019. The fee for standard service will remain at \$60.00 per quarter. The Resolution eliminates the optional bag service program from any new customers and increased the quarterly fee from \$7.50 to \$20.00 for existing accounts. The increased fee will include the delivery of 5 trash bags in January and 5 trash bags in July of each year. Additional bags can be purchased at a rate of \$5.00 per bag. A Resolution has been prepared by the Borough Solicitor to formally authorize the execution of the \$250,000 Tax Anticipation Loan for the 2019 calendar year. The funds should be released on January 2, 2019. The 2019 Budget has been advertised for formal consideration along with the Real Estate Tax Ordinance. The Budget was presented at the November Borough Council meeting and has not been revised since its initial presentation. During the development of the 2019 Budget, Borough Council requested a review of the sewer capacity fees for new connections to the sewer system. The Borough Engineer has recommended an increase from the current fee of \$5,540 per edu to \$8,618 per edu. The Souderton Planning Commission has been working in conjunction with our County Planner in the development of an Outdoor Dining Ordinance. A draft of the outdoor dining regulations has been recommended for formal consideration of Borough Council.

Consideration was given to paying the bills for the month of November, 2018.

He appreciated the hospitality of the community in supporting this annual event and the efforts of the Souderton Police Department and the Souderton Fire Police unit. Daniel Houser complemented Chief Leary for his assistance with the annual Main Streets Holiday Parade. Chief Leary was instrumental in assisting Main Streets with marshals to assist police and fire police through the parade route. Later in the evening approximately 100 people attended the annual Christmas Tree lighting downtown. Weather was certainly challenging for this event.

There being no further public comment, President Goshow moved to the business portion of the agenda, with the first item being approval of the North End Market redevelopment project.

A motion was made by Councillor Jeffrey Gross, and seconded by Councillor Ned Leight, to approve the development plans, last revised November 19, 2018, for the proposed North End Market, 142 N. Main Street, Souderton Borough. The motion was approved.

A motion was made by Councillor Richard Halbom, and seconded by Councillor Julie Munden, to adopt Resolution No. 2018-07 approving a Health Reimbursement Agreement effective December 1, 2018. The motion was approved.

A motion was made by Councillor Richard Godshall, and seconded by Councillor Richard Halbom, to adopt Resolution No. 2018-08 approving a Section 125 Cafeteria Plan and associated Health Savings Account benefit effective December 1, 2018. The motion was approved.

A motion was made by Councillor Richard Godshall, and seconded by Councillor Ned Leight, to adopt Resolution No. 2018-09 establishing fees for municipal curbside collection of solid waste and recycling. The motion was approved.

Councillor Daniel Yocum noted that he will abstain from any discussion concerning the matter of the Tax Anticipation Loan given his employment with Univest Bank and Trust Company.

A motion was made by Councillor Richard Halbom, and seconded by Councillor Richard Godshall, to adopt Resolution No. 2018-10 authorizing the execution of a \$250,000 Tax Anticipation Loan through Univest Bank and Trust Company for the 2019 calendar year. The motion was approved by a vote of 8 yeas and one abstention from Councillor Daniel Yocum.

A motion was made by Councillor Ned Leight, and seconded by Councillor Matt Mscichowski, to adopt Resolution No. 2018-11establishing and approving the annual Budget of the Borough of Souderton for the 2019 calendar year. The motion was approved.

A motion was made by Councillor Richard Godshall, and seconded by Councillor Edward Huber, to enact Ordinance No. 18-738-03 establishing Real Estate Tax Rates for the 2019 calendar year. The motion was approved.

A motion was made by Councillor Richard Halbom, and seconded by Councillor Edward Huber, to authorize the preparation and advertisement of an Ordinance increasing sewer capacity fees for new connections to the sanitary sewer system for formal consideration at the January 7, 2019 Regular Borough Council Meeting. The motion was approved.

A motion was made by Councillor Jeffrey Gross, and seconded by Councillor Edward Huber, to authorize the preparation and advertisement of an Ordinance establishing regulations for Outdoor Dining facilities for formal consideration at the January 7, 2019 Regular Borough Council Meeting. The motion was approved.

There being no further business, the meeting was adjourned at 7:30 pm.
